# HOW TO SUBMIT A NOMINATION

To Run for Alberta Canola Regional Director

STEP 1:	<b>Download</b> the Director Nomination Package.	
STEP 2:	<b>Print</b> the forms. (1 Nomination for Director form and 6 Appointment of Representative forms)	
STEP 3:	Gather signatures from 5 canola growers in your region.	
STEP 4:	<b>Ensure</b> the nominee and each signee completes their Appointment of Representative form <i>(if required)</i> .	
STEP 5:	Submit the completed forms by October 31, 2024.	

Forms must be received by the Alberta Canola Producers Commission office in writing, on or before **October 31, 2024**, at 4 PM. Forms can be submitted via fax, mail, or email.

Please consider submitting your forms ahead of the deadline to provide time for verification that all required elements are included in your submission.

## **INFORMATION ON NOMINATIONS AND ELECTIONS**

## NOMINATIONS

Nominations for Alberta Canola's 20245/2025 fiscal year are open for four regions (3, 6, 9, 12). The regions are identified by municipal district (albertacanola.com/regions). The term of office is 3 years.

Nominations must be received by the Alberta Canola Producers Commission office in writing, on or before **October 31, 2024**, at 4 PM. Forms can be submitted via mail, email, fax, or delivered to the office.

### **ELIGIBLE PRODUCER**

To stand for office, nominate, or vote, the canola grower **must be an eligible producer of the region in which the election is being held.** 

An eligible producer is defined as any producer who has paid a service charge to the commission on canola sold within the previous two crop years.

If you have paid a service charge to Alberta Canola since August 1, 2022, then you are an eligible producer and can let your name stand in 2024.

#### Identifying the Eligible Producer's Region

The Commission identifies the location of eligible producers by mailing address. However, the mailing address within a region does not necessarily mean that a producer either lives, farms or share crops in that region. Eligible producers may also grow canola in more than one region and have the right to specify the region of their choice for electoral purposes provided they have grown canola in that region.

If the nominee has a mailing address outside the region they produce canola, then **please advise our office at the earliest convenience**.

The 3-year term for office commences when the AGM adjourns.

## **Appointing a Representative**

**If an eligible producer is not an individual,** then the corporation, partnership, or organization must:

- 1. Appoint a representative to act on its behalf as an eligible producer in writing
- 2. Notify Alberta Canola so the appointed representative can vote at the AGM, stand for nomination, or hold office.

**A corporation**, shall appoint an individual who is a director, shareholder member, officer or employee of the corporation as its representative.

**A partnership**, shall appoint an individual who is a partner or employee of the partnership as its representative.

**An organization other than a corporation or partnership**, shall appoint an individual who is a member, officer, or employee of the organization as its representative.

# An individual can be the appointed representative for only one eligible producer.

## ELECTIONS

- If one nomination is received for a region, then the nominee will be acclaimed.
- If more than one nomination is received for a region, then there will be an election. An election package with ballots will be mailed to eligible producers for that region by **November 30, 2024**. Ballots must be returned to the Alberta Canola office before 4 PM on January 3, 2025.
- If no nominations are received for a region, then Alberta Canola will call for nominations and hold an election during the Annual General Meeting. If there is a failure to elect a director at the AGM, then the board can appoint an eligible producer to be a director for that region.

# **INFORMATION ON THE RIGHTS OF ELIGIBLE PRODUCERS**

An eligible producer is defined as any producer who has paid a service charge to the commission on canola sold within the previous two crop years.

Eligibility continues unless the producer ceases to pay a service charge to Alberta Canola in two subsequent crop years. Alberta Canola maintains a current list of eligible producers.

#### **GENERAL RIGHTS OF ELIGIBLE PRODUCERS**

- (a) To attend annual region meetings, annual Commission meetings and special Commission meetings;
- (b) To make representations on any matter pertaining to Alberta Canola's regulations and bylaws, the Commission, or the Board of Directors;
- (c) To vote on any matter under Alberta Canola's regulations and bylaws;
- (d) To vote in any election for directors;
- (e) To hold office as a director; and
- (f) To vote on any plebiscites of producers held under the Marketing of Agricultural Products Act.

#### WHO IS AN ELIGIBLE PRODUCER?

- (a) **An Individual** service charge was deducted from canola payment made to an individual who is the eligible producer.
- (b) Not an individual service charge was deducted from canola payment made to a corporation, partnership, or organization. A representative must be appointed.
  - A corporation shall appoint an individual who is a director, shareholder, member, officer, or employee of the corporation as its representative,
  - o A partnership shall appoint an individual who is a partner or employee of the partnership as its representative, or
  - o An organization, other than a corporation or a partnership, shall appoint an individual who is a member, officer, or employee of the organization as its representative.

#### NOTES

- (a) A corporation, partnership, or organization may have only one representative acting as an eligible producer.
- (b) An individual can be the appointed representative for only one eligible producer.
- (c) Eligible Producers that are not an individual must file an Appointment of Representative form with Alberta Canola that appoints a representative who will assume the general rights of an eligible producer on behalf of the corporation, partnership or organization.

## **APPOINTMENT OF REPRESENTATIVE FORM**

#### This form is required if you have sold canola under a name other than your first and last name.

Eligible Producers that are not an individual must file an Appointment of Representative form with Alberta Canola that appoints a representative who will assume the general rights of an eligible producer on behalf of the corporation, partnership, or organization (vote at the AGM, stand for nomination, or hold office.)
